It is to inform that, in pursuance to the Government Orders reference 1st to 4th cited, the Standing Committees of Zilla Praja Parishad, Guntur were initially constituted through a Special Meeting of General Body held on 12-12-2021, vide reference 4th cited.

It is to further inform that, as per Rule 26 of Andhra Pradesh Panchayati Raj Act (Conduct of Election of Members of Standing Committees of Zilla Parishad) Rules, 1995; ***"A casual vacancy in the office of a member of a standing committee of Zilla Parishad shall be filled up within a period of sixty days from the date of occurrence of such vacancy"***.

At this juncture it is to bring to your notice that, the term of Hon'ble Members of Parliament & Legislative Assembly those elected in 2019 was expired on 05-06-2024 and there by eighteen members (three MPs & fifteen MLAs representing rural areas of Erstwhile Guntur District) will cease to be the members of Standing Committees of Zilla Praja Parishad, Guntur. The casual vacancies (Standing Committee wise) are shown below:


